

ARES Net Control Script

Good Evening, this is (CALL - NAME), Net Control for the Nevada County ARES Thursday evening NET. This is a controlled net, and regular users are asked to stand by during the Net.

If there is emergency traffic, please indicate with a call of “BREAK – BREAK”. A “double-break” indicates emergency traffic, and the net will hold until the emergency is finished, or can be moved to another frequency.

From Grass Valley, this net operates on a linked repeater system. For greater Western Nevada County area, the frequency is 147.285, plus offset, and a PL of 136.5 or 151.4. An alternate frequency for Western Nevada County is 147.015, plus offset and a PL of 151.4. From Eastern Nevada County in the Donner / Truckee area, the frequency is 146.640, minus offset and a PL of 131.8.
